RAC #JA22: Are Risks Managed Correctly?

All Risks



1. Must be identified
2. Must be correctly classified
3. Must be on a register
4. Must be monitored
5. Must be regularly reviewed
6. Must be controlled
7. Must be clearly communicated
8. Must never be overlooked or underestimated
9. Must be reviewed before and after a job
10. Must be regularly inspected to ensure controls are effective

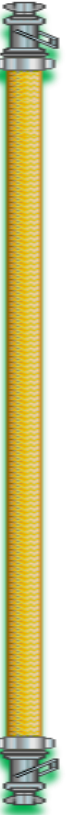

RAC #JA22: Are Risks Managed Correctly?



Risks can change, always monitor:

1. You must always assess your work area for any risks no matter how minor the job may be.
2. You must ensure that you and your team are aware of how to mitigate the risk.
3. You must always take into consideration other risks that may be around your activity.
4. You must ensure that you and your team conduct a Mini Risk Assessment prior to starting work.
5. You must ensure that once conditions of the job change and the risks are no longer within control, that you stop the job and report the changes in conditions as soon as possible, e.g., inclement weather, etc.

RAC #JA22: Are Risks Managed Correctly?



Are you aware?:

1. All Working Environments must identify their risks and put into place measures that mitigate such risks.
2. All Working Environments must review their risks identified at least annually or whenever there is an incident or changes to the working environment.
3. All Working Environments must ensure that all risks no matter how minor they may be, must be clearly communicated to everyone who may be exposed to such risk.
4. Failure to Identify, Manage and Control risks, can and will lead to prosecution.

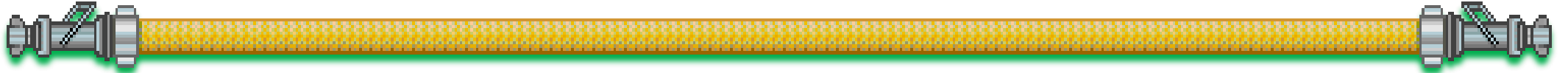
